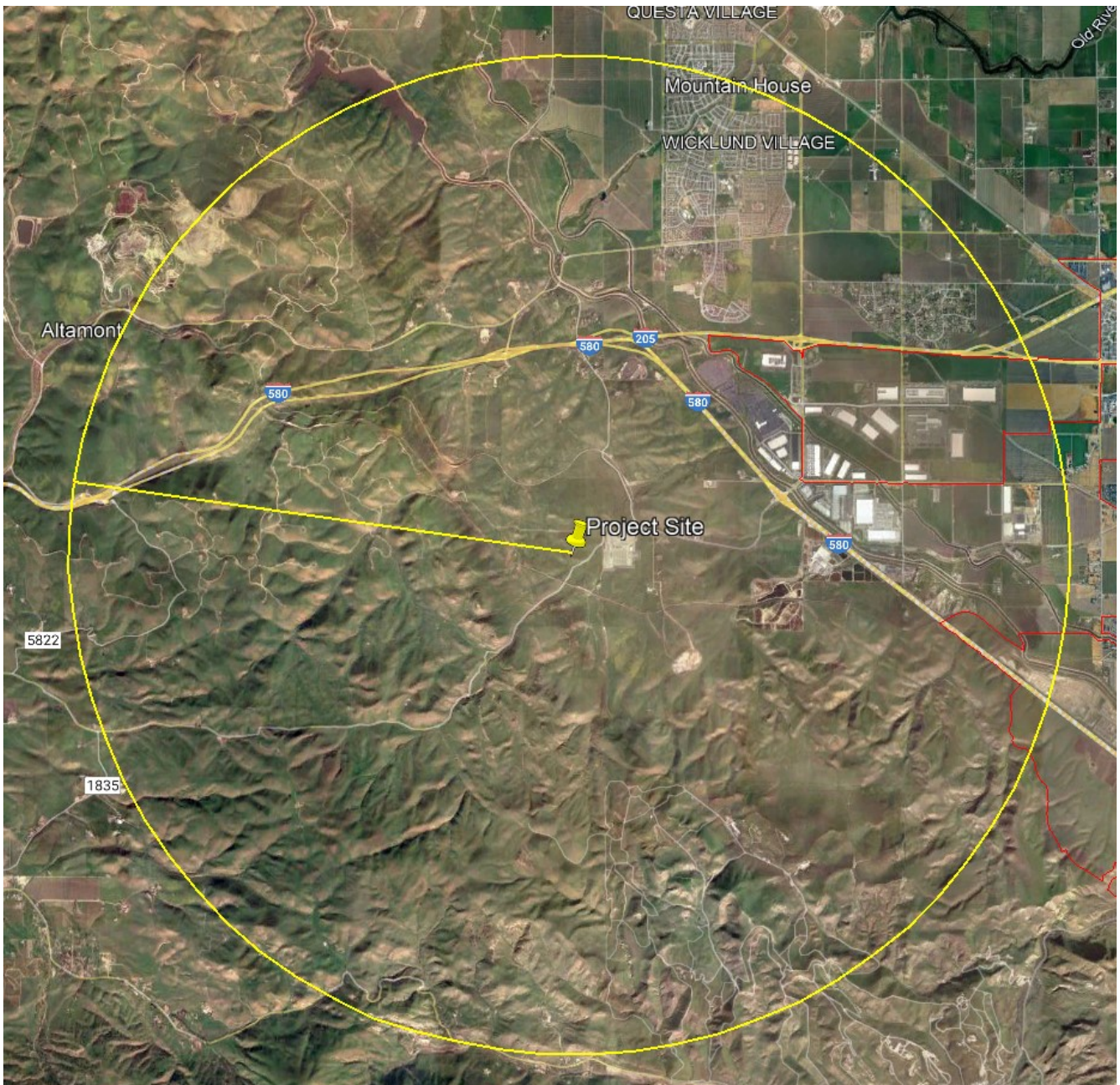

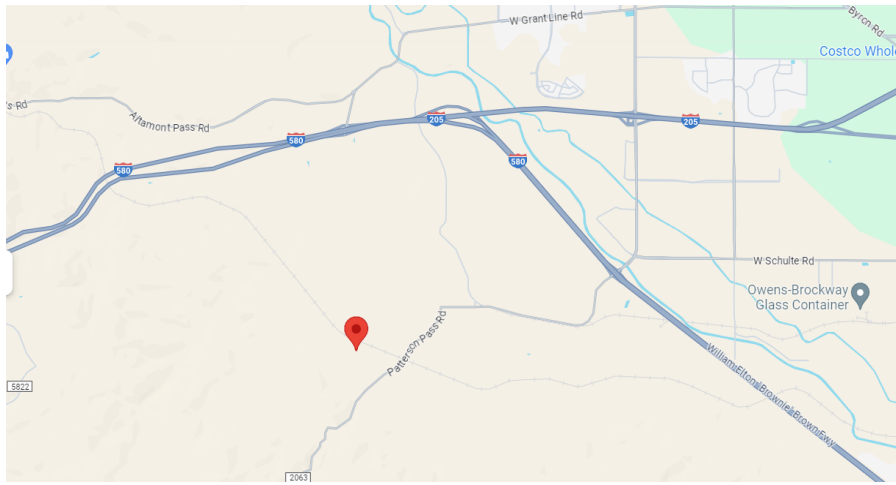

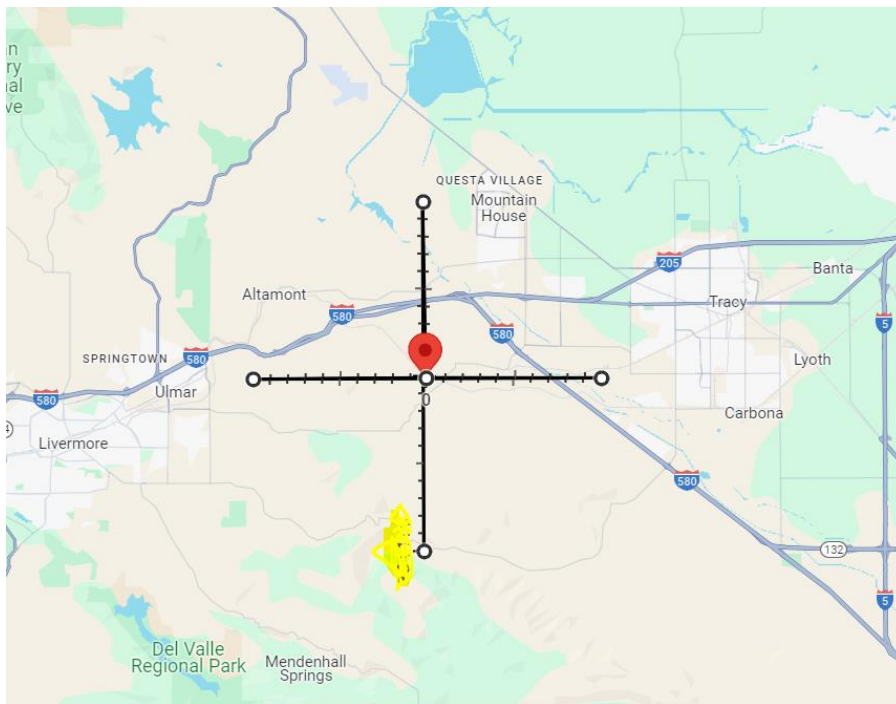

17257 Patterson Pass Road on Google Map

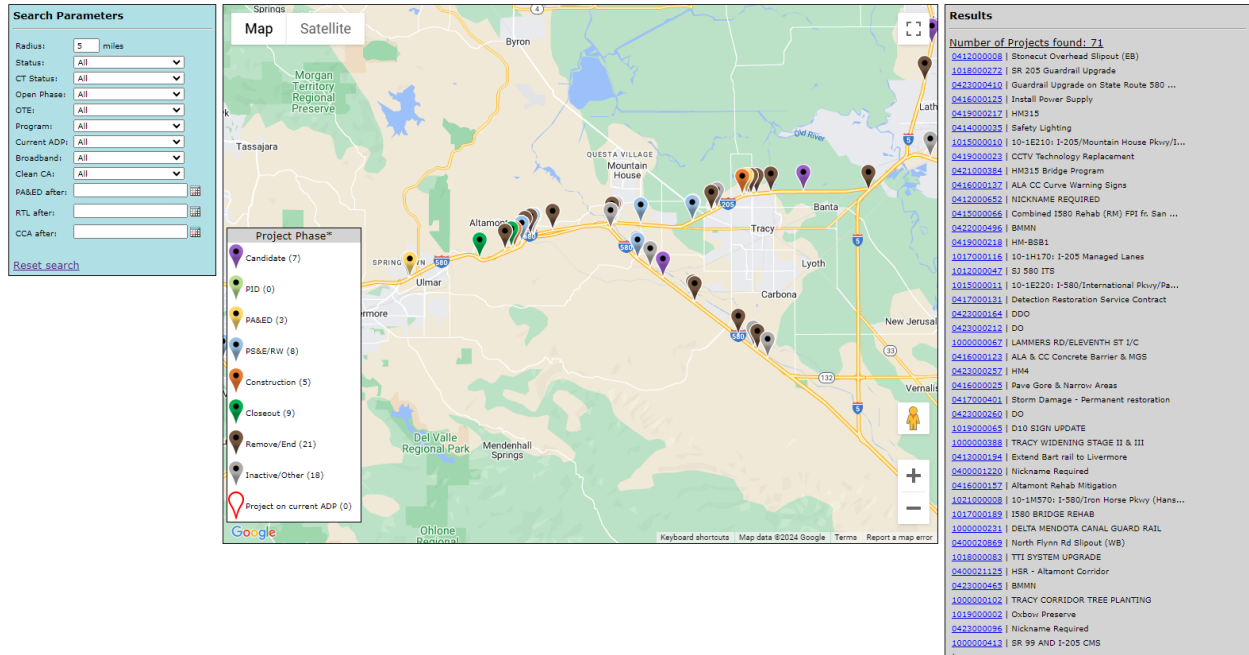


Approximate 5 miles radius from 17257 Patterson Pass Road
