Commercial Energy's customers may be harmed by the loss of confidentiality insofar as members of the public not eligible to review the data as non-market participating parties-primarily other market participants such as other load serving entities-can use this data to derive detailed estimates of Commercial Energy-specific procurement requirements and Commercial Energy's current compliance position.


