# Home Energy Rating and Labeling Calculation Methods September 18, 2024

The California Energy Commission (CEC) will host a second pre-rulemaking workshop to discuss updates to the state's voluntary whole-house Home Energy Rating and Labeling Program. The CEC encourages participation and seeks information from the public in its proceeding to update the program.

The public can participate in the workshop consistent with the attendance instructions below. The CEC aims to begin promptly at the start time posted and the end time is an estimate based on the proposed agenda. The workshop may end sooner or later than the posted end time.

#### **Agenda**

This second pre-rulemaking workshop for the Home Energy Rating and Labeling Program will be focused on the calculation methods needed to support a successful statewide home energy rating program. The workshop will facilitate a discussion around some of the primary needs of the program such as calculating a home's electric and gas consumption for each end-use, estimating energy utility costs, and estimating greenhouse gas emissions using building energy modeling (BEM) software and or other similar methods. The CEC will also present a range of existing calculation methods, standards, and tools that could be applicable to a successful asset rating program. The purpose of this workshop is to solicit feedback and questions from participants specific to home energy rating calculation methods. ## **Background**

Public Resources Code § 25942 directs the CEC to establish a consistent, accurate, and uniform home energy rating system based on a single statewide rating scale for new and existing

residential dwellings. The program is voluntary and intended to assist homeowners, homebuyers, renters, and others in understanding the estimated energy performance of their homes. The program is directed to include reasonable estimates of potential utility bill savings and reliable recommendations on cost-effective measures to improve energy efficiency.

In response to this directive, the CEC created the California Home Energy Rating System (HERS) Program in Title 20 of the California Code of Regulations; specifically, the regulations in sections 1670-1675 pertaining to whole-house home energy rating services. The overall goal of the whole-house Home Energy Rating and Labeling Program is to provide consumers with reliable information regarding the relative energy efficiency of a home. This information is supplemented by cost-effective energy efficiency recommendations which Californians can choose to implement to help them save energy and money on their energy bills. The CEC adopted initial regulations for the whole-house Home Energy Rating and Labeling Program in 2008, and the regulations have not been updated since then.

The CEC is now taking steps to revitalize and modernize the program. Recently, the CEC instituted a rulemaking proceeding to consider amendments to the whole-house Home Energy Rating and Labeling Program to update and improve regulations in support of current state energy efficiency, climate action, and greenhouse gas emission reduction goals. During this pre-rulemaking stage, the CEC is seeking information from stakeholders and the public to inform potential updates to the program. This will be the second pre-rulemaking workshop and will be followed by subsequent workshops.

Note, the HERS Field Verification & Diagnostic Testing Program (also called the Energy Code Compliance Program) will not be discussed during this workshop.
