The California Energy Commission (CEC) will host a kick-off workshop for 24-OIIP-03, CEC's informational proceeding on non-energy impacts. This workshop will provide an objective review of and solicit public input on existing models, tools, and methodologies that inform state resource planning on non-energy impacts.

This is a hybrid meeting with both a publicly accessible physical location and public access online or by phone through Zoom.

The workshop will include discussion of topics related to the inclusion of non-energy impacts in energy system planning. Representatives from government organizations, community members, consultants, and members of academia will present their views.

Background

In response to a petition¹ filed Feb 5, 2024, by a group of sixteen petitioners (the Center for Biological Diversity et al.), the CEC adopted an Order Instituting an Informational Proceeding (OIIP) in March 2024, 24-OIIP-03. The OIIP is to initiate a transparent public process to serve as a forum to inform methodologies to integrate non-energy impacts (benefits and social costs) into CEC planning, processes, and decision making. Including non-energy benefits and social costs provides a more holistic understanding of the impacts of investments and decisions.
