CALIFORNIA ENERGY COMMISSION STAFF AND APPLICANTS' JOINT PROPOSED SCHEDULES

Pursuant to the *Joint Order Directing Parties to Meet and Confer and to Submit a Proposed Schedule* docketed September 17, 2024, Morton Bay Geothermal LLC, Elmore North Geothermal LLC, and Black Rock Geothermal LLC (collectively, "the Applicants") and California Energy Commission ("CEC") Staff jointly propose the following schedules for the remainder of the Morton Bay Geothermal Project ("MBGP"), Elmore North Geothermal Project ("ENGP"), and Black Rock Geothermal Project ("BRGP") proceedings.

I. MEET AND CONFER

On September 24, 2024, the Applicants and CEC Staff met and conferred with intervenors California Unions for Reliable Energy, Supporters Alliance for Environmental Responsibility, and the United Auto Workers regarding the proposed schedule for the remainder of the MBGP, ENGP, and BRGP proceedings and proposals for evidentiary hearings. With respect to evidentiary hearings, parties agreed that the hearings should be held in Imperial County. In general, the Applicants and CEC Staff agree that evidentiary hearings should be held on consecutive days and separated by project. The Applicants and CEC Staff agreed that it may be possible to utilize a hybrid approach, where certain issues are held on certain days, but separated by project.

II. PROPOSED SCHEDULE

The Applicants and CEC Staff jointly propose the following schedules, which include proposed deadlines for CEC Staff to file Final Staff Assessments, the last day to file a petition to intervene, submission of testimony, evidentiary hearings, and prehearing conferences.
