Dear Mr. Bohan,

Pursuant to California Code of Regulations title 20 §1623.1(b)(3), Large CCAs are to submit a list of load flexibility programs the Large CCA deems cost-effective by October 1st, 2024. Among that list, the Large CCAs are to provide at least one option for automating response to MIDAS signals for each customer class that the rate-approving body determines will materially reduce peak load. As detailed in our Load Management Standards Plan,¹ CleanPowerSF does not at this time have any load flexibility programs deemed cost-effective or that would materially reduce peak load through automated response to MIDAS Signals. Thus, the concurrently filed compliance document (CleanPowerSF LMS Load Flexibility Programs List) contains no programs.

CleanPowerSF supports the Load Management Standards' goals of reducing peak-load, improving grid reliability, and reducing greenhouse gas emissions, among others. We will continue to evaluate load flexibility programs and are considering participation in the Real-Time-Pricing pilots authorized by California Public Utilities Commission (CPUC) Decision 24-01-032. CleanPowerSF will make a determination whether to participate in the pilots by the CPUC's March 1, 2025 deadline.
