Executive Director Bohan,

Sonoma Clean Power Authority (SCP) is pleased to provide our list of load flexibility programs pursuant to the California Code of Regulations, Title 20 §1623.1(b)(3). The list comprises our GridSavvy Rewards demand response program, and the information provided parallels SCP's Load Management Standards (LMS) Compliance Plan, submitted March 7, 2024.

GridSavvy Rewards operates as SCP's event-based demand response program, launched in 2022. The program serves as a critical tool to collaboratively benefit the grid, reduce greenhouse gas impacts, and deploy affordability resources. GridSavvy Rewards provides multiple participation options, including automated demand response using integrated and dispatchable smart thermostats and EV chargers, and a behavioral demand response option known as GridSavvy Alerts. GridSavvy resources of all types are called upon based on the California Independent System Operator's Day-ahead demand forecast.

GridSavvy Alerts allow customers to participate without the need for additional technologies. Unlike other available offerings, no upfront investment in technology is needed to participate, which allows customers to engage with the program option and earn rewards for participating with no upfront costs and no penalties for not participating. Through an integrated and multimodal approach, SCP customers are able to choose how they will reduce use in their home when asked to do so in response to a peak demand event. SCP continues to see high impact value of and ongoing participation in GridSavvy Alerts, which provides a means for participation to customers across socio-economic classes and diverse populations throughout SCP's service territory.

SCP strongly supports the intent and goals of the LMS regulation and has been working toward parallel goals through our Integrated Resource Plan, where we are striving to match hourly demand with GHG-free resources from our power supply by 2030. SCP enthusiastically pursues such goals through existing programs like GridSavvy and aims to develop new programs and pilots in future years.
