The California Energy Commission (CEC) will host a staff workshop to present the outlook for natural gas reliability for the winter months of 2024-25, the Winter 2024-25 Gas System Reliability Assessment.

The public can participate in the staff workshop consistent with the attendance instructions below. The CEC aims to begin promptly at the start time posted and the end time is an estimate based on the proposed agenda. The workshop may end sooner or later than the posted end time.

### **Agenda**

The workshop will be divided into two portions with the first portion consisting of CEC and the California Public Utilities Commission (CPUC) providing presentations on the findings from their respective analyses regarding winter 2024-25 reliability. During the second portion, the gas utilities and independent storage providers will provide their perspectives for winter 2024-25 in comparison to the CEC and CPUC findings while informing planners and other attendees of any possible concerns with reliability. There will also be time reserved for question and answers (Q&A) and public comment.

## Background

The CEC has prepared or taken a lead role in several seasonal gas system reliability assessments since April 2016, with a focus on the Southern California Gas Company (SoCalGas) territory. The CEC staff's Winter 2024-25 Gas System Reliability Assessment provides an independent analysis of the expected reliability of service in Winter 2024-25 for both the Pacific Gas & Electric Company (PG&E) and SoCalGas systems. This analysis will help guide planning decisions and prepare California for different natural gas demand scenarios from November 2024 through March 2025. This is the first assessment that includes a winter analysis of the PG&E system.
