Subject: Open New Docket for the 2025 Energy Code Compliance Software, Manuals and Forms

The Efficiency Division requests a new docket to facilitate updates to documents supporting California's 2025 Building Energy Efficiency Standards. The Building Energy Efficiency Standards serve to reduce wasteful, uneconomical, and unnecessary uses of energy within the state. They include requirements in the Energy Code (Title 24, Parts 1 and 6) and voluntary energy efficiency provisions in CALGreen (Title 24, Part 11). The Building Energy Efficiency Standards are updated every three years. This specific docket is intended to record public engagement during the development of Compliance Software, Manuals and Forms related to the 2025 Energy Code. The documents and resources that will be addressed in this docket cover single-family, multifamily, and nonresidential occupancies and include:

- California Building Energy Code Compliance (CBECC & CBECC-Res) Software
- Alternative Calculation Method Reference Manuals
- Compliance Manuals
- Compliance Documents, commonly referred to as Forms
- Data Registry Requirements Manual
