The California Energy Commission (CEC) will host a workshop to gather feedback from interested parties on a potential Charging Interoperability and Collaboration Yard Funding Solicitation (hereinafter referred to as "Charge Yard"). This is the first pre-solicitation workshop on this solicitation. The Charge Yard solicitation proposes an open and neutral industry facility designed to support charging interoperability, implementation of global standards, advancement of next generation charging features, and industry collaboration.

Background

On May 5th, 2023, the CEC hosted a Charging Interoperability and Collaboration Yard Funding <u>Workshop</u> where staff proposed to fund a facility that will provide an open and neutral space for industry collaboration, knowledge sharing, interoperability testing, and conformance testing for ISO 15118. Numerous <u>written comments</u> were submitted in response to the workshop. The upcoming workshop will present the solicitation design based on the feedback received.

Charging interoperability describes the ability of different vehicles, chargers, and other charging related systems to function together without special effort from the user. Despite market progress toward standardized connectors and communication protocols, charging interoperability remains a challenge. Interoperability challenges may become a barrier to a seamless driver experience as customers and industry demand more advanced charging capabilities, such as "Plug and Charge" and bidirectional charging.
