## Background

Senate Bill (SB) 1477 (Stern, Chapter 378, Statutes of 2018) authorized two building decarbonization programs to encourage the development and deployment of near-zero-emission building technologies: the BUILD Program and the Technology and Equipment for Clean Heating (TECH) Initiative. BUILD is a residential building decarbonization program that provides technical

assistance and incentives to support the adoption of advanced building design and near-zero emission technologies in new all-electric, low-income residential buildings. The BUILD Program is overseen by the California Public Utilities Commission (CPUC) and administered by the CEC.

The Draft Second Edition Guidelines contains substantive and non-substantive changes to the Building Initiative for Low-Emissions Development (BUILD) Program Guidelines, First Edition.
