The California Energy Commission (CEC) Efficiency Division will host a public workshop to discuss proposed standards for water closets (more commonly referred to as toilets) and to seek comments from interested members of the public regarding the draft staff report, *Analysis of Proposed Efficiency Standards for Water Closets (Toilets)*. The draft staff report includes proposed standards and staff's analysis. The proposed standards for water closets would be considered as amendments to the Appliance Efficiency Regulations (Title 20, Code of Regulations, Sections 1601 through Section 1609).

Background

On October 12, 2022, the CEC adopted an order instituting rulemaking (OIR) for water closets to consider modifying existing efficiency standards, test procedures, marking requirements, and other efficiency measures found in the Appliance Efficiency Regulations (California Code of Regulations, Title 20, Sections 1601–1609).

On December 14, 2022, the CEC released a request for information and invitation to submit proposals on standards and other measures to improve the efficiency of water closets.

Staff has evaluated all comments and proposals received, conducted analyses of the comments, data, and proposals, and prepared a draft staff report posted on the <u>Water Closets Docket Log</u>, at https://efiling.energy.ca.gov/Lists/DocketLog.aspx?docketnumber=22-AAER-05.
