Re: Update 2024 Integrated Energy Policy Report (“IEPR”): Request for Extension of Time to File Electricity Resource Plan Reporting Forms

Dear Executive Director Bohan,

Ava Community Energy (“Ava”) respectfully requests an extension of time to submit the Electricity Resource Plan Forms in the 2024 IEPR update, under the process set forth in the California Code of Regulations, Title 20, Article 2, Section 1342.

The types of demand forecasts and the dates for submittal are detailed in the "Supply Forms Instructions," docketed by the California Energy Commission (CEC) on July 30, 2024, in docket number 24-IEPR-02.¹

The current filing deadline for the Electricity Resource Plan Forms is November 15, 2024. Ava requests an additional 7 calendar days to submit the following forms, with justifications for the requests provided below.
