CleanPowerSF requests the same confidentiality designation for the information provided in this year's Supply forms because the information is substantially similar to the information previously submitted in its 2022 Supply forms, and all the facts and circumstances relevant to confidentiality remain unchanged from those in CleanPowerSF's 2022 Application for Confidentiality. As explained in its 2022 Application, CleanPowerSF relies on Government Code sections 7927.705 (formerly 6254(k)) and 7922.000 (formerly 6255(a)) and Evidence Code section 1060 as the basis for confidentiality of the information identified in this Repeated Application.

I. Identification of Confidential Information

CleanPowerSF requests confidentiality for certain information provided in the following Supply Forms:

- Form S-1, Capacity/Energy Requirement;
- Form S-2, Capacity/Energy Supply Resources; and
- Form S-2A, Addendum Monthly Capacity and Energy Data

The data for which CleanPowerSF seeks confidential designation in S-1, S-2, and S-2Ais clearly highlighted in yellow, and the confidential file is conspicuously labeled as "Confidential." CleanPowerSF is not requesting confidentiality for information in Form S-5, Bilateral Contracts Table.

Similar to CleanPowerSF's 2022 Supply forms, the information provided in this year's Supply forms falls into two broad categories: 1) information related to CleanPowerSF's Resource Adequacy (RA) obligation, forecasts, and projected compliance; and 2) CleanPowerSF's energy demand forecasts and projected Renewables Portfolio Standard (RPS) compliance. The following identifies the specific data for which CleanPowerSF requests confidential designation.

a. Form S-1, Capacity/Energy Requirement

The confidential information in Form S-1 includes the "Peak Load Calculations" and related inputs. Specifically, Lines 1, 5-8, and 11, Columns I-R. It also includes the "Energy Demand Calculations" and related inputs. Specifically, Lines 12, 16, and 18, Columns I-L.

b. <u>Form S-2, Capacity/Energy Supply Resources</u>

The confidential information in Form S-2 includes the "Total Renewable Contract Supply" and the contract supply and energy information from individual contracts well as the Capacity/Energy Balance Summary which consists of "Total: Existing and Planned Supply," "Firm LSE Procurement Requirement," and "Net Surplus (or Need)." c. Form S-2A, Addendum Monthly Capacity and Energy Data

The confidential information in Form S-2A includes the monthly "Contract GWh" and the "NQC MW" data for each resource.

II. Time Period for Confidential Treatment

CleanPowerSF requests confidential treatment for the following time periods, which parallel the amount of time that CleanPowerSF protects its forecasts in California Public Utilities Commission (CPUC) supply data submissions:

- RA data: Three (3) year forecast period until December 31, 2027;
- RPS data: Current year and a two (2) year forecast period; and
- RA capacity forecasts: Current year, plus ten (10) year forecast period.

For RA capacity forecasts, CleanPowerSF requests confidentiality for the current year plus 10-year forecast period (2024-2033) because it keeps this data confidential where those years of the contract would reveal the capacity amount for each year. CleanPowerSF's CPUC annual procurement obligations for capacity are also kept confidential. The capacity data constitutes valuable, highly-sensitive market information because it would provide significant insight into CleanPowerSF's procurement obligation and current and forecasted energy needs. Release of the information would allow dominant market participants to exercise market power and manipulate compliance with the CPUC's RA program. As a consequence, it would severely compromise and negatively impact CleanPowerSF's ability to negotiate and procure RA capacity on terms reasonable for its ratepayers. Given the sensitivity of this data, the public interest served by disclosing capacity information is clearly outweighed by the public interest in withholding such information from disclosure.

III. Certification of CleanPowerSF Director

I certify that the information submitted in CleanPowerSF's 2025 Electricity Resource Plan Supply forms is substantially similar to the previously submitted information in CleanPowerSF's 2022 Electricity Resource Plan Supply forms, and that all the facts and circumstances relevant to confidentiality remain unchanged.

I certify under penalty of perjury that the information contained in this application for confidential designation is true, correct, and completed to the best of my knowledge. I also certify that I am authorized to make the application and certification on behalf of CleanPowerSF.
