**ORDER GRANTING PETITION TO INTERVENE FILED BY  
JOBS TO MOVE AMERICA**

Upon consideration of the Petition to Intervene (Petition)<sup>1</sup> filed by Jobs to Move America (JMA or Petitioner) in the application for certification (AFC) proceeding for the proposed Elmore North Geothermal Project (Elmore North, or Project),<sup>2</sup> the California Energy Commission (CEC) committee designated to conduct proceedings in this matter (Committee)<sup>3</sup> makes the following findings:

2. The Petition contains the information required by the CEC's regulations.<sup>4</sup>
3. JMA's Petition states JMA intends to participate in all topics relevant to the CEC's consideration of the Project including, but not limited to air quality, biological resources, greenhouse gas emissions, cultural and tribal cultural resources, hazardous waste, public health, worker safety, socioeconomics, water resources, environmental justice, and transportation. JMA reserves the right to participate in other topics as well.<sup>5</sup>
4. No opposition to the Petition has been filed, and the deadline for such opposition was October 23, 2024.
5. Petitioner has demonstrated a bona fide interest in the Project and has demonstrated possession of information or expertise that may help the Committee in preparing a proposed decision.
6. Petitioner's stated interests are relevant to the above-captioned proceeding.
7. The Committee has discretion to grant intervention to the degree that it finds intervention reasonable and relevant. The Presiding Member or Committee may impose conditions on all intervenors' participation to promote the orderly conduct of the proceeding.
8. JMA requests permission to participate in all aspects of this proceeding including discovery, workshops, testimony, briefing, and cross examination of witnesses. The Committee notes that at this point discovery is closed and will not be reopened.

**THEREFORE**, the Committee **ORDERS** that the Petition be **GRANTED** and that Petitioner may participate on the following topic areas as requested:

- **air quality**
- **biological resources**
- **greenhouse gas emissions**
- **cultural and tribal cultural resources**
- **hazardous waste**
- **public health**
- **worker safety**
- **socioeconomics**
- **water resources**
- **environmental justice**
- **transportation**

The Committee further **ORDERS** that Petitioner's name be placed upon the Project's Proof of Service List as an intervenor. Petitioner may exercise the rights and shall fulfill the obligations of a party as set forth in all orders issued in the proceeding and California Code of Regulations, title 20, section 1211.7(a). Deadlines and other matters shall not be extended or changed by the granting of the Petition.<sup>6</sup>

Petitioner's intervention is subject to modification at the discretion of the Presiding Member or the Committee. The CEC welcomes and values intervenor participation in its energy facility siting process. As an intervenor, Petitioner is required to file and serve documents on other parties and to follow the CEC's procedures and orders regarding presenting witnesses and evidence. Petitioner is further required to review the rules regarding filings, the rules of evidence that apply at the Evidentiary Hearings, and the rules prohibiting off-the-record contacts with commissioners, their advisors, or the hearing officer(s) about the Project. Petitioner's failure to fulfill these responsibilities may result in the Committee limiting or precluding Petitioner's participation in the proceedings.
