**Subject: Open New Docket for the 2025 Energy Code Compliance Initiatives**

The Efficiency Division requests a new docket to document and facilitate public interaction regarding compliance with California's 2025 Energy Code. California Energy Commission (CEC) staff will host a series of compliance-focused workshops and seek public feedback on a number of CEC-led initiatives aimed at enhancing compliance with the Energy Code over time. This initiative follows the recent adoption of the 2025 Building Energy Efficiency Standards by the CEC. California's Building Energy Efficiency Standards include building energy efficiency requirements in the Energy Code (Title 24, Part 6) and voluntary building energy efficiency standards in CALGreen (Title 24, Part 11). The Building Energy Efficiency Standards serve to reduce wasteful, uneconomical, and unnecessary uses of energy within the state. The Building Energy Efficiency Standards are updated every three years. This specific docket is intended to record public engagement on the topic of Energy Code compliance and is not associated with a formal rulemaking.
