The California Energy Commission (CEC) will host a remote-access workshop to review CEC progress on 2025 Energy Code compliance initiatives and seek public collaboration and feedback on these efforts. The workshop will be publicly accessible online or by phone through Zoom™.

The public can participate in the workshop consistent with the attendance instructions below. The CEC aims to begin promptly at the start time posted and the end time is an estimate based on the proposed agenda. The workshop may end sooner or later than the posted end time.

Agenda

The CEC will present a general overview of initial findings from past compliance improvement efforts following the 2025 Energy Code Compliance Tools Staff Workshop held on March 22, 2022. The CEC will also provide an overview of ongoing CEC-led projects to help improve statewide compliance with the 2025 Energy Code. An overview will be provided of programs being developed to assist building departments, and efforts to develop online 'web-forms' versions of current PDF compliance documents. During this first workshop, additional workshops will be proposed on the topics of compliance tools, compliance and enforcement, and compliance analysis. CEC staff will attempt to incorporate optional live polling as part of the workshop, intended to give more opportunity for stakeholder engagement. There will also be time reserved for public comment.

Background

The Building Energy Efficiency Standards serve to reduce wasteful, uneconomical, and unnecessary uses of energy within the state. California's Building Energy Efficiency Standards include building energy efficiency requirements in the Energy Code (Title 24, Part 6) and voluntary building energy efficiency standards in CALGreen (Title 24, Part 11). The Building Energy Efficiency Standards are updated every three years.

This Energy Code Compliance Initiatives workshop follows the recent adoption of the 2025 Building Energy Efficiency Standards by the CEC. The CEC has previously held workshops on Energy Code compliance, including the Energy Code Compliance Workshop on March 22, 2022. Throughout the public process, the CEC has received feedback from stakeholders indicating concerns around compliance rates as well as the process for complying with the Energy Code. Based on this feedback, CEC staff have been developing projects and programs to better analyze and improve compliance with the Energy Code over time.

To support these efforts, CEC staff intends to host a series of compliance-focused workshops and seek public feedback on a number of CEC-led initiatives aimed at enhancing compliance with the Energy Code over time. This workshop is intended to solicit public engagement and feedback on Energy Code compliance and is not associated with a formal rulemaking.
