**Revised Notice of Meeting**

This is a revised notice of a public meeting of the Disadvantaged Communities Advisory Group (DACAG) to the California Energy Commission (CEC) and the California Public Utilities Commission (CPUC). The DACAG aims to begin the meeting promptly at the start time, and the end time is an estimate based on the agenda proposed. The meeting may end sooner or later than the posted end time depending on various factors.

The meeting will convene with DACAG members in person at the primary physical meeting location in Sacramento, California. The public may participate remotely as instructed below or physically attend at the primary physical meeting location. The meeting may be recorded.

- 11) DACAG 2025 Meeting Schedule: DACAG member discussion on a) 2025 meeting cadence b) the feasibility of hosting in-person DACAG and regional engagement meetings.
