Valle Undio Coalition Letter in Support of the Southeast Lake Cahuilla Active Volcanic Cultural District.

Valle Unido por Beneficios Comunitarios (Valle Unido) is a coalition of residents, community-based organizations, unions, and environmental justice advocates fighting for a clean environment, healthy communities, and good, family-sustaining jobs in California's "Lithium Valley." Our platform also calls for Lithium Valley companies to respect the rights of Indigenous Peoples and protect tribal cultural resources. We respectfully submit this letter for your consideration at the December 9 public workshop on tribal mitigation for the Morton Bay, Elmore North, and Black Rock geothermal projects.

Based on extensive documentation and tribal consultation, the CEC staff has found in its Preliminary Staff Assessments (PSAs) for the projects that the Southeast Lake Cahuilla Active Volcanic Cultural District (SELCAVCD) Landscape qualifies as a Tribal Cultural Resource (TCR). Valle Unido strongly supports that finding. We also believe that the record supports that the cultural property also qualifies as a Traditional Cultural Place (TCP). In both instances, the evidence supports eligibility for the California Register of Historical Resources and the National Register of Historic Places.

We urge the California Energy Commission (CEC) to fully analyze, avoid where possible, and mitigate all the projects' impacts to this important TCR/TCP. We also urge the CEC to identify mitigation and culturally-appropriate treatment in consultation with culturally-affiliated tribes. Such measures must benefit the TCR and culturally-affiliated tribes and reflect the values and priorities of those tribes – not those of archaeologists or industry consultants.

In solidarity with the Indigenous Peoples on whose ancestral lands these geothermal plants, and ultimately lithium valley, will be developed, we urge the CEC to retain its TCR finding for the SELCAVCD and consult with culturally-affiliated tribes on all appropriate avoidance and mitigation measures.
