Thanks again for clarifying this with me yesterday (and over the phone).

We are not intending on submitting comments, but informally I wanted to give the feedback that I think the rules could benefit from adding this clarity that you provided for me. I understood how these 3 factors play into the emissions *intensity* for annual unspecified power (revised section 1392 (b)(4)) but it wasn't clear that these would also be used to calculate the % for the unspecified source categories. Possibly a minor addition that could improve clarity.

Hello Shelby,

Jordan is out of the office until Wednesday, but I can help with answering your questions. Among the proposals in the Power Source Disclosure rulemaking are the following two points:

1) PSD is proposing to group all resources on the power content label into two larger supercategories, either *fossil fuels* or *renewables and zero-carbon resources*, and to display that information in pie charts as shown in this <u>sample PCL</u>.

2) PSD is also proposing to calculate and display on the PCL the percentage of fossil fuels or renewables and zero-carbon resources that comprised unspecified power.

To determine the percentage of unspecified power that came from these two supercategories, the PSD program is proposing to use three data points:

1) Annual in-state natural gas generation that retail suppliers did not purchase as a specified resource through an existing contract. This in-state gas is presumed to be sold on the open market to meet marginal retail demand.

2) Annual unspecified imports (presumed to be all fossil fuels).

3) Oversupply, which is specified generation reported by retail suppliers in excess of their total load and losses. This excess generation is presumed to help meet the demand of other retail suppliers that relied on unspecified power.

PSD would use QFER data to determine unclaimed in-state gas and unspecified imports, and would use PSD annual reports to determine oversupply.
