Dear James Bezek:

The California Energy Commission (CEC) received Solano County's request for reimbursement letter and estimate of expenses for review of the Corby Battery Energy Storage Project (24-OPT-05) Opt-In Certification Application on December 4, 2024. Pursuant to California Code of Regulations, title 20, section 1878.1(c)(3), the CEC is notifying you that the proposed budget is incomplete. The following deficiencies must be corrected to complete the proposed budget request:

1. To apply for reimbursement, a local agency is required to, within 21 days of receiving a request for review from the commission, file an itemized proposed budget with the staff and the applicant estimating the actual and added costs that are likely to be incurred during such review. While the CEC received a copy of the proposed budget request, the applicant did not. Please provide the applicant a copy of the proposed budget request.
2. The proposed budget is also required to justify each line-item amount and explain how each line-item is reasonably related to the matters which the agency is requested to review. Attachment A – BESS Tracking, page 1 identifies line-item costs for multiple categories. However, the proposed budget does not include justification for each line-item budget amount and how it is reasonably related to the matters which the agency is requested to review. Please update your request to include this information.

- Attachment A identifies line-item costs by categories. Please provide sufficient detail for each line-item category. As an example, please identify the expenses included in the "Loss of Revenue from Permits/Development Impact Fees Not Received" by line-items in addition to the total amount for that category.

"To apply for reimbursement, a local agency shall, within 21 days of receiving a request for review from the commission, file an itemized proposed budget with the staff and the applicant estimating the actual and added costs that are likely to be incurred during such review. The proposed budget shall justify each line item amount and explain how each line item is reasonably related to the matters which the agency is requested to review. A local agency's failure to file a proposed budget within the time period specified herein shall not prevent it from receiving reimbursement; however, failure to use the approval process described in this section creates a risk that the local agency will not be reimbursed for work already performed."

Costs eligible for reimbursement include permit fees, including traffic impact fees, drainage fees, park-in-lieu fees, sewer fees, public facilities fees, and added costs of services performed directly in response to commission requests for review that are not normally covered by the permit fee and for which a fee is normally charged. Eligible costs do not include processing fees that the local agency would normally receive for an application for a facility as defined in Public Resources Code section 25545(b) in the absence of commission jurisdiction.

Pursuant to California Code of Regulations, title 20, section 1878.1 (b), costs ineligible for reimbursement include: (1) expenses incurred by a local agency for the presentation or defense of positions not reasonably related to the matters that the agency is requested to review or not within the area of the agency's expertise, including attorneys' fees and costs associated with advocating for or against commission approval of the facility; (2) expenses for which it receives payment from other sources; and (3) entertainment and first class travel expenses.

4. Attachment A Timesheets identifies hours before the CEC's requests for comments, and in some cases, before the project's opt-in application was filed. The CEC sent a notice of receipt of opt-in application and request for comments and information to the County on November 13, 2024. Expenses incurred prior to a commission request for review or expenses incurred for review beyond the scope of the commission request are not eligible for reimbursement. The timesheets included in Attachment A included time for:
- i. Hours worked prior to CEC's receipt on November 7, 2024, of an opt-in application for the Corby Battery Energy Storage System Project (24-OPT-05).
 - ii. Hours worked prior to the request for information and comments on November 13, 2024.
 - iii. Hours for a "press release" which is beyond the scope of the Commission request.
 - iv. Time for an "LUTC" meeting on November 19, 2024. It is unclear what the "LUTC" meeting is and how it is related to the review of the application.

To complete the proposed budget request process under California Code of Regulations, title 20, section 1878.1, please submit a revised proposed budget correcting the identified deficiencies. The County of Solano (“County”) submits this Reimbursement Request for the actual and proposed costs associated with its review of and comments on the Corby Battery Energy Storage System Project (“Project”) Opt-in Application (“Application”) filed by Corby Energy Storage, LCC (“Applicant”).

I. Reimbursement Request Justification

The AB 205, or “Opt-in,” statute states that Public Resources Code section 25538 applies to an application submitted under the Opt-in Program administered by the California Energy Commission (“CEC”). (Pub. Res. Code, § 25545.8.) Public Resources Code section 25538 provides that:

Upon receiving the commission's request for review under subdivision (f) of Section 25519 and Section 25506, the local agency may request a fee from the commission to reimburse the local agency for the actual and added costs of this review by the local agency. The commission shall reimburse the local agency for the added costs that shall be actually incurred by the local agency in complying with the commission's request... The commission shall either request a fee from the person proposing the project or devote a special fund in its budget, for the reimbursement of such costs incurred by local agencies.

Public Resources Code section 25519(f) requires CEC staff to forward the Opt-in application to local government agencies that are required to, “review the application and submit comments on, among other things, the design of the facility, architectural and aesthetic features of the facility, access to highways, landscaping and grading, public use of lands in the area of the facility, and other appropriate aspects of the design, construction, or operation of the proposed site and related facility.” On November 13, 2024, Solano County received a letter from CEC staff requesting the County’s input pursuant to Public Resources Code section 25519(f) and on Opt-in Program specific provisions under California Code of Regulations, title 20, section 1877.

Solano County's Reimbursement Request is set forth in detail in **Attachment A**. The Reimbursement Request lists a description of the various activities the County has conducted or will conduct consistent with its obligations under Public Resources Code section 25519(f), and as requested by the CEC on November 13, 2024. All line items in the proposed budget represent actual costs incurred to date, and a detailed estimate of anticipated activities, sub-activities, and costs eligible for reimbursement under Public Resources Code section 25538 and applicable law. The proposed budget is based on a reasonable estimate of time and resources necessary to perform tasks eligible for reimbursement, which includes cost estimates from staff, counsel, and anticipated proposals by environmental and technical consultants.

II. Reimbursement Request: Costs Incurred To-Date, including Initial Review of Project Application and County Comment Letter Submitted December 2, 2024.

The CEC's November 13, 2024, letter asked for County comments on the Corby BESS Opt-In Application at the County's "earliest convenience." Additionally, at the October 2, 2024, Opt-In Pre-Application Meeting, CEC staff advised the County that comments should be submitted in advance of the CEC's application completeness determination—which the County understands to be December 9, 2024—to ensure meaningful consideration.

In response to these requests from the CEC, the County submitted its initial comment letter on December 2, 2024. The County will submit further comments in the coming months consistent with its obligations and rights under law, including Public Resources Code section 25519(f) and California Code of Regulations, title 20, section 1877, once the County has adequate time to fully review the Application and any subsequent submittals but the Applicant.

The County is seeking reimbursement for its review of the Application and preparation of the County's December 2, 2024, comment letter. This includes time and costs for County staff in its Department of Resource Management, Department of Agriculture, Office of Emergency Services staff, County Administrator's Office, and the Office of County Counsel.

The County's review and comments to-date—for which it now seeks reimbursement—directly relate to the Application's compliance with California Code of Regulations, title 20, section 1877, and the Project's proposed design, construction, and operation. The County's review and proposed costs do not include the County's review or preparation of the Reimbursement Request. A detailed breakdown of eligible costs incurred through December 4, 2024, is included in **Attachment A**.

III. Reimbursement Request: Added Costs for Further and Supplemental Review, Including Analysis, Review, and Comments on Net Positive Economic Benefits, Community Benefits Plan and Agreement(s), Environmental Impacts, Design, Construction, and Operation of the Project, and Whether the Project is Required for the Public Convenience and Necessity

The County is seeking further reimbursement under Public Resources Code section 25538 for its estimated added costs associated with its further review of the Application consistent with California Code of Regulations, title 20, section 1877 and Public Resources Code section 25519. This includes further review and comments regarding (1) the purported net positive economic benefit of the Project; (2) the community benefits plan and agreement(s); (3) County environmental impacts; (4) the design, construction, and operation of the Project; and (5) whether the Project is required for the public

convenience and necessity. **Attachment A** includes an estimated breakdown of costs eligible for reimbursement under Public Resources Code section 25538 for each of categories.

IV. Development Impact and Permit Fees

The County is also authorized to seek reimbursement for “permit fees, including traffic impact fees, drainage fees, park-in-lieu fees, sewer fees, public facilities fees and the like, but not processing fees,” that the County would normally receive but-for the opt-in process. (Cal. Code Regs., tit. 20, §1878.1(a)(1)(A). At this time, the County is still evaluating what fees would apply to the proposed 300 MW BESS facility, and has provided its best estimate in **Attachment A**. The County will seek reimbursement to the extent authorized by law.

V. Conclusion

The County requests that the Commission deem this Reimbursement Request complete and authorize reimbursement consistent with Public Resources Code section 25538. The County appreciates the Commission’s attention to this request. Should you have any questions or concerns, please don’t hesitate to contact me. We look forward to working with the CEC to complete this process.
