(D) Reason for Extension Request

This is the first instance in which the California Energy Commission (CEC) requests SVP to file the Transmission Form T-1. Regrettably, we were unaware of the CEC's request for the Transmission Form T-1 submittal and missed both the November 15, 2024 deadline and the window for submitting an application for extension of deadline. Once we were aware of the Transmission Form T-1, SVP reached out to CEC staff regarding its submittal and was informed that SVP must submit the form and to either (1) submit immediately or (2) submit a request for extension even if it fell beyond the 15-day requirement to file a request per section 1342(c)(1).

SVP will need additional time to collect, validate, and accurately compile the information requested. SVP respectfully requests an extension to February 28, 2025 to allow for comprehensive compliance with all regulatory requirements.

We are fully committed to diligently working together to complete the form by the requested deadline, ensuring full compliance with all applicable requirements. In addition, SVP timely filed other requested IEPR Supply forms S-1, S-2, and S-2A by the November 15th deadline.
