In 2004, the CPUC designated the CEC as an administrator for the gas research fund (Decision 04-08-010), which includes surcharges from consumers who receive gas services from investor-owned utilities. This fund supports public interest research and development through the Gas R&D Program. The CEC develops a proposed budget for the Gas R&D Program each year.
