The California Energy Commission (CEC) and the California Department of Transportation (Caltrans) will host a workshop to solicit feedback on California's West Coast Truck Charging and Fueling Corridor project, funded by the federal Charging and Fueling Infrastructure (CFI) Program grant funding opportunity. During the workshop, CEC staff will present concepts for a future solicitation to increase charging and refueling infrastructure needed to support medium- and heavy-duty (MDHD) zero-emission vehicles (ZEV).

The public can participate in the workshop consistent with the attendance instructions below. The CEC aims to begin promptly at the start time posted and the end time is an estimate based on the proposed agenda. The workshop may end sooner or later than the posted end time.

Agenda

The workshop will include a staff presentation on the proposed structure and requirements for the California's West Coast Truck Charging and Fueling Corridor grant funding opportunity, funded by the federal CFI Program. Discussion topics will include funding levels, requirements, geographic consideration, and solicitation release timing. Public comments will be heard after staff presentations to gather feedback before a solicitation is released.

Background

The federal CFI Program is a competitive grant program funded by Bipartisan Infrastructure Law and administered by the Federal Highway Administration (FHWA) to strategically deploy publicly accessible electric vehicle (EV) charging and alternative fueling infrastructure. Caltrans, in

partnership with the CEC, Oregon Department of Transportation, and Washington State Department of Transportation were awarded \$102 million under Round 1B for the West Coast Truck Charging and Fueling Corridor project from the federal CFI Program. The West Coast Truck Charging and Fueling Corridor project will deploy MDHD ZEV infrastructure along interstate corridors across all three states. The CEC will implement California's portion of the award in the form of competitive funding solicitation(s).
