Reclaimed Wind LLC (Applicant) submits this Opt-In Application (Application) for the Viracocha Hill Battery Energy Storage System (Viracocha Hill BESS) through the Opt-In Certification Process under Assembly Bill 205 (AB205). The Viracocha Hill BESS is located near the city of Livermore, Alameda County, California. Reclaimed Wind LLC proposes to construct, operate, maintain, and decommission a 362.8 megawatt-hour (MW-hr) BESS project on private land located within the Altamont Pass Wind Resource Area (APWRA).

The Viracocha Hill BESS would help balance electricity generation from all sources, including but not limited to wind and solar, with electricity demand by storing excess generation from all power sources and delivering it back to the grid when demand exceeds real-time generation supply, thereby assisting the State of California's (State) grid reliability needs, while assisting in the transition to a 100 percent renewable energy and zero-carbon grid by 2045.
