

### SB 48 Strategy & Recommendations

## **Building Energy Performance Strategy Report and Recommendations**

- ✓ Submit to Legislature before August 1, 2026
- ✓ Include recommendations for further legislative action

SB 48 Requires CEC Staff to "...develop a strategy for using benchmarking data to track and manage the energy usage and emissions of greenhouse gases of covered buildings in order to achieve the state's goals, targets, and standards..."



### SB 48 Required Engagement

## Public Resources Code § 25402.16(d)...the commission shall consider input from... all of the following:

- Under-resourced communities and community-based organizations
- 2) City and county governments
- Affordable housing owners and operators
- 4) Low income and small commercial tenant representatives
- 5) Energy service and equipment providers

- 6) Labor unions
- 7) Technical building design professionals
- 8) Facility operations professionals
- 9) Multiunit residential building owners
- 10) Nonresidential building owners
- 11) Energy utilities



## SB 48 Required Engagement

SB 48 requires the CEC to "...ensure equitable participation and input from stakeholders representing under-resourced communities, low-income residential tenants, and small commercial tenants in the development of..." the report and recommendations.






