The California Energy Commission (CEC) will host a scoping workshop for CEC's Informational Proceeding on Non-Energy Benefits and Social Costs (NEI OIIP). The NEI OIIP is continuing its public process serving as a forum to determine methodologies to integrate non-energy impacts (benefits and social costs) (NEIs) into CEC planning, processes, and decision making. This workshop will seek public input on the proposed scope of NEIs for consideration.

This is a hybrid meeting with both a publicly accessible physical location and public access online or by phone through Zoom.

## **Background**

In response to a petition<sup>1</sup> filed Feb 5, 2024, by a group of sixteen petitioners (the Center for Biological Diversity et al.), the CEC adopted an Order Instituting an Informational Proceeding (OIIP) in March 2024 under Docket No. 24-OIIP-03. The purpose of this OIIP is to initiate a transparent public process to serve as a forum to inform methodologies to integrate non-energy impacts (benefits and social costs) into CEC planning, processes, and decision making. Including non-energy benefits and social costs provides a more holistic understanding of the impacts of investments and decisions.
