The California Energy Commission (CEC) will host a remote-access workshop to present and gather feedback on the Draft Consultant Report on Sea Space Analysis for Wave and Tidal Energy for Senate Bill (SB) 605 (Padilla, Chapter 405, Statutes of 2023). SB 605 directs the CEC to evaluate the feasibility, costs, and benefits of wave and tidal energy off the coast of California. The public can participate in the workshop consistent with the attendance instructions below. The CEC aims to begin promptly at the start time posted and the end time is an estimate based on the proposed agenda. The workshop may end sooner or later than the posted end time.

### **Agenda**

The workshop will include a staff presentation of the draft consultant report, which will be posted for public review before the workshop, followed by a period for public comment. ## **Background**

Senate Bill 605 requires the California Energy Commission (CEC), in consultation with other state agencies pursuant to Public Resources Code, section 25996(a), to evaluate the following six points in the *2024 Integrated Energy Policy Report (IEPR) Update*. The CEC will consult with California Native American tribes pursuant to the CEC Tribal Consultation Policy on this evaluation related to wave and tidal energy.

1. Evaluate factors that may contribute to the increased use of wave and tidal energy in California.
2. Provide findings on latest research about the technological and economic feasibility of deploying offshore wave and tidal energy off the coast of California in state and federal waters.
3. Evaluate wave and tidal energy project potential transmission needs and permitting requirements.
4. Evaluate wave and tidal energy project economic and workforce development needs.
5. Identify near-term actions related to investments and workforce for wave and tidal projects, to maximize job creation and economic development, while considering affordable electric rates and bills.
6. Identify a monitoring strategy to gather sufficient data to evaluate impacts to marine and tidal ecosystems and inform adaptive management.

Further, SB 605 requires the CEC to submit a separate report to the Governor and Legislature that summarizes the *2024 IEPR Update* findings, the identification of suitable sea space, and adaptive management measures for wave and tidal energy projects to inform legislative and executive actions on the topic. This work is to be completed in two phases and utilizes two different dockets for public participation, as described below.

The first phase of this work evaluating the six points listed above is included in the *2024 IEPR Update*, which utilizes an IEPR docket (Wave and Tidal Energy: Docket No. 24-IEPR-04). All documents and public comments specific to the *2024 IEPR Update* are located within the IEPR docket (24-IEPR-04). This docket will close upon adoption of the *Final 2024 IEPR Update*.

SB 605 also requires the CEC to complete a second phase of work to identify suitable sea space for wave and tidal technologies, identify mitigation measures, and evaluate monitoring and adaptive management strategies. This work is not a part of the *2024 IEPR Update*. Additionally, SB 605 requires the CEC to submit a final written report to the Governor and Legislature that includes a summary of the IEPR chapter on wave and tidal energy and a summary of sea space identification and mitigation and monitoring strategies (i.e. draft consultant report). The CEC report to Governor and Legislature will also include considerations that may inform legislative and executive actions to facilitate, encourage, and promote the development and increased use of technologically and economically feasible wave energy and tidal energy technologies, infrastructure, and facilities in the state.
