## WILDFLOWER LARKSPUR ENERGY FACILITY (01-EP-01C)

On August 12, 2024, Wildflower Energy L.P., parent entity Diamond Generating Corporation, project owner, filed a post certification petition (TN 258467) with the California Energy Commission (CEC) requesting to transfer ownership, name change and operational control of the Wildflower Larkspur Energy Facility (LEF) from Diamond Generating Corporation to Larkspur Energy, LLC. The name change will be from Wildflower Larkspur Energy Facility.

The 90-megawatt project was certified by the California Energy Commission (CEC) on April 4, 2001, and began commercial operation on July 16, 2001. The LEF (01-EP-01C) is located at 9355 Otay Mesa Road in the City of San Diego, San Diego County, California.

A statement describing the change in ownership, name change and operational control, was signed under penalty of perjury by Paul Shepard, the President of Larkspur Energy, LLC, and was submitted in accordance with California Code of Regulations, Title 20, section 1769(b) and 1707. The statement affirms that the project owner understands the conditions of certification in the Commission Decision or as previously amended and agrees to comply with those conditions.
