STATEMENT OF STAFF APPROVAL CHANGE IN OWNERSHIP, NAME CHANGE AND OPERATIONAL CONTROL WILDFLOWER INDIGO ENERGY FACILITY (01-EP-02C)

On August 12, 2024, Wildflower Energy L.P. parent entity Diamond Generating Corporation, the project owner, filed a post certification petition (TN 258468) with the California Energy Commission (CEC) requesting to transfer ownership, name change and operational control of the Wildflower Indigo Energy Facility (IEF) from Diamond Generating Corporation to Indigo Generation, LLC. The name change will be from Wildflower Indigo Energy Facility to Indigo Energy Facility.

The 135-megawatt project was certified by the California Energy Commission (CEC) on April 4, 2001, and began commercial operation on September 10, 2001. IEF (Docket No. 01-EP-02C) is located at 63500 19th Avenue, North Palm Springs, Riverside, California.

A statement describing the change in ownership, name change and operational control, signed under penalty of perjury by Paul Shepard, President, Indigo Generation, LLC, was submitted pursuant to California Code of Regulations, Title 20, section 1769(b) and 1707. The statement affirms that the project owner understands the conditions of certification in the Commission Decision or as previously amended and agrees to comply with those conditions.
