Transmission Forms and Instructions (T-1)

- The CEC is compiling statewide information on transmission projects 100 kV and larger for the 2025 IEPR
- Form T-1 is informed by the data template for the CPUC's Transmission Project Review Process and CPUC Resolution E-5252. The fields have not changed from last year's Form T-1.
- There will be information (columns) in Form T-1 that do not apply to every project or transmission owner; the form now explicitly indicates whether a field is required, optional, or not applicable.

Changes for 2025

- Inclusion of county column
- More battery technology subtypes
- Instruction Clarification:
 - Not using Slice of Day (SOD)
 - Hybrid technology – only report grid power
 - S-5 worksheet is not auto populating
 - Transmission form checkbox removed from S-5



Instruction Clarification (continued)

- All categories of RECs (0,1,2,3) are acceptable
- Transmission Form T-1, submit form even if nothing to report;
- Storage duration hours – only report hours at full power operation
