The California Energy Commission (CEC) will host a remote access workshop to present the Kindergarten through Twelfth Grade School Energy Efficiency (KTEP) Program Opportunity Notice (PON). This program is providing zero-interest loans to Kindergarten–Twelve Grade schools (K-12) in California. This workshop will provide interested parties with information on the PON and application process.

The public can participate in the workshop consistent with the attendance instructions below. The CEC aims to begin promptly at the start time posted and the end time is an estimate based on the proposed agenda. The workshop may end sooner or later than the posted end time.

### **Agenda**

Staff will provide an overview of the KTEP Program and present the PON. The presentation will cover topics including program background, eligibility requirements, and application and reporting requirements. There will be an opportunity for the public to ask questions and provide comments.

### **Background**

Funds offered in this PON are made available by the Federal Infrastructure Investment and Jobs Act (IIJA), also referred to as the Bipartisan Infrastructure Law (BIL), Public Law No. 117-58,

enacted on November 15, 2021. Section 40502 of BIL states that the purpose of this provision is to establish revolving loan funds under which states can provide loans and grants for energy upgrades and retrofits to increase the energy efficiency, physical comfort, and air quality of existing infrastructure.

The KTEP program provides funds to finance energy efficient K-12 grade school retrofits and renewable energy projects. This zero-interest loan program is offered to help schools improve their energy efficiency and switch to efficient-electric equipment. The PON was released on April 23, 2025, and is accepting applications.
