On October 12, 1993, Sacramento Cogeneration Authority (SCA) composed of the Sacramento Municipal Utility District (SMUD) and Sacramento Municipal Utility District Financing Authority (SMUDFA) submitted an Application for Certification to the California Energy Commission (CEC) for its proposed Procter & Gamble Cogeneration Project.

**PROJECT SUMMARY**

The proposed Procter & Gamble Cogeneration Project is to be developed by the SCA. It consists of a natural gas-fired combined cycle cogeneration power plant (171 megawatts (MW) nominal gross capacity).

The Procter & Gamble Cogeneration Project is proposed to be located on a ten acre site near the intersection of Power Inn Road and Fruitridge Road in the city of Sacramento. The Central California Traction Company rail line borders the site on the north, and 83rd Street borders the site on the east. Power Inn Road is approximately 0.4 mile to the west, and Fruitridge Road is approximately 0.35 mile to the south.

**COMMISSION REVIEW PROCEDURES**

The purpose of the AFC process is to enable the Commission to make a determination regarding the need for the project, and to assess the project's proposed design and engineering, compliance with all applicable laws, and impact on environmental quality and public health and safety.

The CEC staff is currently reviewing the AFC to determine if the application is complete pursuant to Public Resources Code (PRC), section 25520 and Commission regulations. If the AFC document is accepted as adequate for review, the Commission must, within 12 months, make a decision on the AFC to either grant or deny certification.

Following acceptance of the AFC, the CEC will sponsor public hearings to discuss the proposed project. Prior to the commencement of formal hearings, the CEC staff will sponsor public workshops with SCA and other interested parties to identify, discuss, and attempt to resolve issues, problems, and concerns regarding the project. The CEC staff will prepare an assessment

of the project which will be the subject of public hearings and comment. Members of the public can become formal parties to the proceedings by filing a petition to intervene.

Notices of workshops and hearings will be mailed to those individuals and organizations who have expressed an interest and whose names appear on the CEC's project mailing list. If you wish to receive notices regarding this proceeding, please complete the attached form and return it to the CEC as soon as possible.


AVAILABILITY OF THE AFC DOCUMENT
