On October 12, 1993, the proposed Procter & Gamble Cogeneration Project Application for Certification (AFC) was filed. The purpose of these workshops is to discuss the adequacy of the data contained in the AFC.

The California Energy Commission (Commission) at its regularly scheduled business meeting, on November 17, 1993, will determine if the AFC is data adequate. Before considering the merits of the application, the Commission, under Public Resources Code § 25522 (b), shall determine within 45 days after it receives the application whether the application is complete. This workshop will allow the CEC staff, applicant and other interested parties to discuss the completeness of the AFC in preparation for its recommendation to the Commission.

The proposed Procter & Gamble Cogeneration Project is to be developed by the Sacramento Cogeneration Authority (SCA), composed of the Sacramento Municipal Utility District (SMUD) and Sacramento Municipal Utility District Financing Authority (SMUDFA). It consists of a natural gas-fired combined cycle cogeneration power plant with a nominal gross capacity of 171 megawatts.

The Procter & Gamble Cogeneration Project is proposed to be located on a ten acre site near the intersection of Power Inn Road and Fruitridge Road in the city of Sacramento. The Central California Traction Company rail line borders the site on the north, and 83rd Street borders the site on the east. Power Inn Road is approximately 0.4 mile to the west, and Fruitridge Road is approximately 0.35 mile to the south.


