MINOR MODIFICATION TO THE PROCTER & GAMBLE AFC 93-AFC-2: DELETION OF STANDBY GENERATOR AND CHANGE IN MAXIMUM POLE HEIGHT FOR THE TRANSMISSION LINE

Dear Mr. Woo:

The Sacramento Cogeneration Authority would like to make some minor modifications to the Procter & Gamble Cogeneration Project. These modifications are listed below.

### Standby Generator

The first modification is to delete the standby generator from the project. After further analysis, the Sacramento Cogeneration Authority has determined that the generator is not needed.

### Transmission Line

The proposed transmission line for the Procter & Gamble Cogeneration Project crosses PG&E's existing Rio Oso/Bellota 230kV transmission line approximately .25 miles east of the Procter and Gamble site (see Figure 3.15-6 in the Procter and Gamble Cogeneration Project AFC).

For the past several months, SMUD has been working with PG&E to develop the design requirements for SMUD's crossing of the PG&E transmission line. SMUD and PG&E have determined that the existing PG&E transmission line profile will not allow the proposed transmission line to cross underneath the existing line and still maintain clearances from the ground and to the existing line. The requirement for ground clearance is in accordance with CPUC Rules for Overhead Line Construction - G.O. 95. As a result, PG&E has requested that SMUD's proposed transmission line cross over the top of the existing PG&E line.

In order to accommodate PG&E's request, two steel poles approximately 170' high, will be located on each side of the PG&E line. The maximum pole height for the remaining poles for the proposed transmission line will be approximately 150', as specified in the AFC.

Although the Procter & Gamble Cogeneration Project AFC stated that the transmission line would be routed beneath the PG&E line, the steel pole height changes should not change the impact assessment contained in the AFC. This is because the location where the proposed transmission line crosses the PG&E line was not determined to be a key observation point. The location of the crossing of the two lines is approximately 1,650 feet west of Florin Perkins Road and 2,700 feet north of Fruitridge Blvd. Traversing the industrialized area are several distribution lines and poles.
