The California Energy Commission (Commission), the Sacramento Cogeneration Authority (Applicant), and other interested parties will hold a public workshop to discuss biological impacts associated with the Procter & Gamble Application for Certification (AFC). If necessary, a visit to the proposed site may follow.

The proposed project consists of a natural gas-fired combined cycle cogeneration power plant with a nominal capacity of 171 megawatts. The project is proposed to be located on a ten-acre site near the intersection of Power Inn Road and Fruitridge Road in the City of Sacramento.

The staff workshop is being held as a part of the Commission's comprehensive review of the Applicant's AFC. The cogeneration plant and related facilities are under the Commission's siting authority. For purposes of the California Environmental Quality Act, the Commission is the lead agency for the entire project.

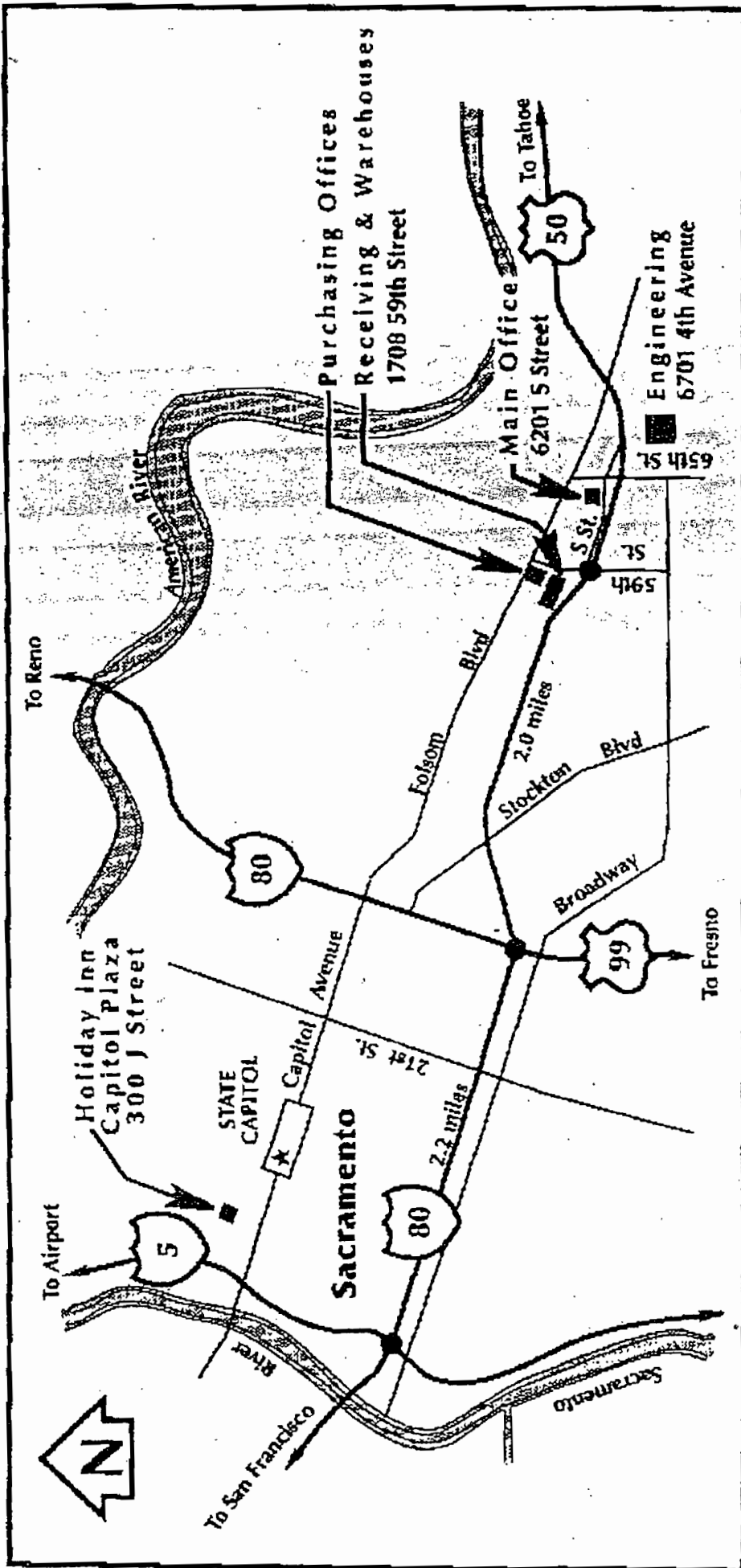


