DATA REQUESTS

Pursuant to Title 20, California Code of Regulations (CCR) section 1716, the California Energy Commission (Commission) staff requests that the Sacramento Cogeneration Authority (Applicant), supply the information specified in the enclosed set of water resources data requests. The information is necessary for a complete analysis of the Procter & Gamble Cogeneration Project with regard to environmental impacts and mitigation, engineering design, and compliance with the applicable laws, ordinances, regulations and standards.

Written responses to the enclosed data requests are due to the Commission by June 9, 1994, or at such later date as may be agreed upon by staff and Applicant.

If you are unable to provide the information or object to providing it, you must, within 15 days of receiving these requests, send a written notice of you inability or objection(s) to both Commissioner Sharpless, Presiding Member of the Committee for this proceeding, and me. The notification must also contain the reasons for not providing the information and the grounds for any objection. [See Title 20 CCR section 1716(e), on the 15-day notice requirements for responding parties.]

The following information is needed to allow staff to prepare an accurate analysis of the project:

Water Res-2 The Applicant, on April 7, 1994, filed a proposal to replace the evaporative cooling system for the simple cycle turbine with a steam absorption chiller. With the attendant increased size of the cooling tower, and increased flow rate, the project's demand for cooling water will increase.

In order to determine the water use as a result of the changes proposed in your April 7, 1994 filing, the applicant is requested to provide updated versions of the following AFC tables and figures:

- o Table 3.9-1, Estimated Average Daily Water Requirements-Cogeneration Facilities, page 3-29;
- o Table 3.9-2, Estimated Peak Daily Water Requirements-Cogeneration Facilities, page 3-30;
- o Table 3.10-1, Wastewater Quality-Discharge to City Sewers, page 3-35;
- o Figure 3.9-1 Daily Average Water Mass Balance, page 3-27; and
- o Figure 3.9-2 Peak Average Water Mass Balance, page 3-28.

Water Res-3 At the April 29, 1994, Campbell Soup Application for Certification (AFC) workshop, a proposed water contract between the city of Sacramento, Sacramento County and the Sacramento Municipal Utility District was discussed.

Please provide an explanation of this proposed contract. When will the water contract be finalized? Discuss what, if any, ramifications, both physical and operational, the finalized contract will have on the Procter & Gamble Cogeneration Project, beyond those described in the proposed AFC.


