On June 20, 2013, K Road Calico Solar, LLC, filed a letter with the California Energy Commission (Energy Commission) requesting to withdraw an existing Petition to Amend and also requesting to terminate the Energy Commission certification for the Calico Solar Project. K Road Calico Solar has indicated that changes in market conditions will not allow the project to move forward as currently licensed or as proposed to be amended.

The 663.5-megawatt project was licensed by the Energy Commission on December 1, 2010. The proposed project would have been located on a 4,613-acre site in San Bernardino County, approximately 37 miles east of Barstow and 17 miles east of Newberry Springs, north of Interstate 40.

**CONCLUSION AND ORDER**

There being no objection and good cause having been shown, the California Energy Commission hereby grants the request of K Road Calico Solar to withdraw the existing Petition to Amend and terminate the Commission certification, effective June 20, 2013.


