Subject: Save the Date (November 18, 2013) for Committee Hearing

I am finalizing a formal notice but want to give you a head's up that the Committee Hearing on the Bottle Rock Amendment Petition will be held on Monday, November 18, 2013, at the Cobb Mountain Lion's Club/Community Center in Cobb. One of my reasons for giving this head's up is to alleviate any anxiety about the November 4 date given in the Committee Schedule for the filing of prehearing statements, identification of witnesses, etc. You will have until at least November 8, possibly November 12 (the 11th is a State holiday), for the initial filing and November 14 or 15 for rebuttal filings.

We haven't settled on a start time for the hearing on the 18th. You can help with that. Our current projection is that no more than 4 hours will be necessary for testimony, questions, and argument from the parties, with public comment to follow in the early evening. If you think more time may be necessary, please let me know.

As you go about assembling your evidence, remember that documents already filed in this proceeding (79-AFC-04C) need not be filed again; you can simply give us the TN number. If you want to use a new document or one filed in another proceeding (i.e., the Bottle Rock Complaint), you'll need to upload it in this proceeding so that we can assign it an exhibit number for this case. Each exhibit must be uploaded as a separate document. As you will need to provide a TN number for each document on your exhibit list, you should upload the exhibits ahead of the deadline to give time for their TN numbers to be assigned. Remember that any written testimony you file needs to be given an exhibit number as well. My office will then enter the exhibit numbers in the e-filing system, after which you can generate an Exhibit List, with clickable links to the documents, from the link on the Bottle Rock web page.

We are going to set up WebEx telephonic access but we're not sure how well that is going to work at this site. There will be no internet access unless you bring your own cellular modem (and cell service is said to be spotty). By coming back to the project vicinity, we're hoping that most everyone will be able to attend in person.
