Application for Confidential Designation

Pursuant to 20 CCR § 2505 and the California Energy Commission's Standing Order re: Proceedings and Confidentiality Applications - Procedural Requirements for Filing, Service, and Docketing Documents with the Energy Commission, the Colorado River Indian Tribes (CRIT or the Tribes), a federally recognized Indian tribe, hereby apply to designate the following documents confidential for purposes of the above-captioned proceeding:

- Exhibit 4012: Statement of Weldon B. Johnson, Sr. 1.
- 2. Exhibit 4013: Statement of Stacia Bailey

CRIT requests that these records be kept confidential indefinitely. CRIT members and Tribal Elders shared this information with CRIT counsel based on the understanding that it would be kept confidential, as it contains private information regarding religious practices and sacred sites. Numerous state and federal laws protect the confidentiality of Native American sacred site information, including the California Public Records Act (Gov. Code § 6254.10), the Archaeological Resources Protection Act (16 U.S.C. § 470hh) and the National Historic Preservation Act (16 U.S.C. § 470w-3(a)) (both federal acts incorporated into the Public Records Act by Gov. Code § 6254(k)).

CRIT recognizes that CEC Staff Counsel may take the position that these statements are not protected by these specific laws, as the statements contain information that relates only indirectly to sacred sites. While CRIT disagrees with this narrow interpretation, CRIT requests that the Commission take the same approach as in the Palen Solar Electric Generating System proceeding. In this approach, the Commission would consider these documents as confidential for the purposes of this proceeding. To the extent any other parties would like to review the documents, they would be subject to a non-disclosure agreement provided by CRIT. None of the Tribal Elders making statements intend to testify; the testimony of Wilene Fisher-Holt, CRIT's cultural resource witness, has been made publically available.

This information is kept confidential by those persons supplying testimony, except with other CRIT members and members of other affiliated tribes and with Tribal staff and counsel for the purpose of protecting CRIT culture.
