Subject: STAFF'S DATA ADEQUACY RECOMMENDATION FOR THE ALAMITOS ENERGY **CENTER, (13-AFC-01)** 

Staff has completed its data adequacy review of the AFC and has determined that it does not meet all the requirements listed in Title 20 California Code of Regulations, section 1704. Appendix B (2007) for the 12-month process. Of the 23 technical disciplines reviewed, staff determined the information contained in the AFC is deficient in four areas: Air Quality, Biological Resources, Cultural Resources, and Transmission System Engineering.

On December 27, 2013, AES Southland Development, LLC (AES-SD) submitted an Application for Certification (AFC) to the California Energy Commission to replace the existing Alamitos Generating Station (AGS). The Alamitos Energy Center (AEC) would be located on the AGS site in the city of Long Beach, Los Angeles County, California on approximately 63 acres of privately owned land. The proposed project site is bounded on the north by State Route 22, on the east by the San Gabriel River, on the south by 2<sup>nd</sup> Street, and on the west by N. Studebaker Rd.

The Notice of Receipt was mailed out on January 14, 2014, to the agencies, nearby property owners, the public mailing list, and the project listserve. The only comment received to date is the letter of incompleteness submitted by the South Coast Air Quality Management District dated January 21, 2014.

The AEC is a proposed natural gas-fired, fast starting, combined-cycle gas-turbine, aircooled generating facility with a net generating capacity of 1,936 megawatts (MW) and gross generating capacity of 1,995 MW. The project would consist of four 3-on-1 combined-cycle gas-turbine power blocks of twelve natural gas-fired combustion-turbine generators, twelve heat recovery steam generators, four steam-turbine generators, four air-cooled condensers, and related ancillary equipment. The AEC is proposed to use air-cooled condensers for cooling, eliminating the existing ocean water once-through cooling system. The AEC is proposed to use potable water provided by the city of Long Beach Water Department for construction, operational process, and sanitary uses. This water would be supplied through existing onsite potable water lines.

Attached are a summary table and the data adequacy worksheets for all technical disciplines. The worksheets for the data inadequate sections identify the additional information that staff believes is necessary to complete the AFC in accordance with our regulations. At the Energy Commission's business meeting on February 18, 2014, I will recommend that the Energy Commission adopt the staff's list of deficiencies and not accept the AFC as complete until the additional information specified in the staff's data adequacy worksheets is supplied.
