BACKGROUND

Staff requested in Data Requests 26R and 28R (TN No. 201267 dated 11/20/2013) that the applicant perform additional noise monitoring at northerly and easterly locations of the project site in order to more precisely establish the existing ambient noise levels at the residences located north and east of the project site. On February 3, 2014, the applicant responded in their Data Response Set 1C (TN No. 201628) that they would perform additional long-term monitoring at locations on Herondo Street equidistant between North Francesca Avenue and the Pacific Coast Highway (PCH) and at the intersection of Beryl Street and North Broadway. These locations are consistent with those described in Data Requests 26R and 28R; they are labeled M3 and M4 (see Data Response Set 1C, TN No. 201628). In addition to this ambient noise monitoring data, staff needs to know the expected operational noise levels from the proposed project alone at M3 and M4 in order to fully analyze the project's noise impact at these locations.
