Subject: El Segundo Energy Center, El Segundo Power Facility Modification (00-AFC-14C): Project Owner's March 28, 2014 Response to Data Request 78

Staff has reviewed the project owner's Confidential Cultural Resources Data Response (Supplemental Response to CEC Data Request 78), filed March 28, 2014, for the aforementioned project (ESEC 2014b). In conducting its review, staff consulted Data Request 78 and all related correspondence (CEC 2013:25; ESEC 2013:55; ESEC 2014a; Roark 2014). Although the project owner conducted records searches that included a 1-mile buffer surrounding the proposed project site and all staging areas, a 1-mile radius was required only for the project site; staff deemed 0.25-mile buffers surrounding the project components to be sufficient for its analysis (Roark 2014). Staff examined the project owner's entire submittal, including its table of records at the South Central Coastal Information Center, and noted there is missing information. Staff finds that ESEC (2014b) does not contain all of the information requested in Data Request 78. Specifically, staff finds that all or portions of 23 previous cultural resources studies are missing from ESEC (2014b) and DPR 523 forms are lacking for five previously recorded cultural resources (see attached tables). Additionally, the project owner indicates that four previous cultural resource studies are present within 1 mile of the project site (LA-8882, LA-9177, LA-11301, and 11055), but staff has not found these studies in the submitted records search materials nor on the supplied records search maps (see ESEC 2014b:Table DR78-1R1).

Staff discussed the missing data referenced above with the project owner at the April 22, 2014 Preliminary Staff Assessment Workshop. The project owner agreed at the workshop to obtain these remaining pieces of information so staff can complete the Final Staff Assessment.
