Edison Mission Energy ("EME") hereby notifies the California Energy Commission ("Commission") that it has entered into an agreement with NRG Energy, Inc. ("NRG") and NRG Energy Holdings Inc. ("NRG Holdings") pursuant to which NRG Holdings will acquire substantially all of EME's assets, including its direct and indirect interests in various Commission-licensed facilities, subject to the satisfaction of certain conditions. Among the assets to be transferred to NRG are the ownership interests listed on Exhibit A to this letter. Upon closing, NRG Holdings will acquire all of EME's indirect interests in these facilities. The transaction is anticipated to close on March 6, 2014. Following the close of the transaction, NRG may transfer all or a portion of the assets it is purchasing through the transaction to its publicly-traded affiliate, NRG Yield, Inc. ("NRG Yield"). NRG Yield was formed to own a diversified portfolio of contracted renewable and conventional generation and thermal infrastructure assets in the United States. NRG owns 65.5 percent of the voting interests in NRG Yield. The outstanding shares of NRG Yield not held by NRG are publicly traded.
