Background and Purpose of Prehearing Conference

The May 21, 2014 Committee Order Granting Petitioner's Motion to Reopen the Evidentiary Record and Setting Revised Schedule limited the scope of the evidentiary hearing to the following issues:

- a. Avian impacts
- b. Flying invertebrate species (insects)
- c. Curtailment provision
- d. Avian deterrent strategies
- e. Visual Resources (glint and glare)
- f. Alternatives (PPA milestone status and economic feasibility)
- g. Overriding considerations
- h. Natural gas consumption
- i. Cultural Resources mitigation (Condition of Certification **CUL-1**)

The Prehearing Conference is a public forum where the Committee will assess the parties' readiness for an evidentiary hearing, identify areas of agreement or dispute, and discuss the remaining schedule and procedures necessary to conclude the amendment process. (Cal. Code Regs., tit. 20, § 1718.5.)

At the Prehearing Conference, all parties (Staff, Applicant, and Intervenors) shall present their respective positions regarding the limited issues listed above that are ready for evidentiary hearing, those limited issues listed above that require further analysis, including the nature of, and time frame for, any such analysis, and any of the limited issues listed above that have been resolved. The parties shall also identify proposed witnesses, as well as the estimated time required for expert testimony, open discussion amongst the experts, and questions.

Local, state, and federal governmental agencies may participate at the Prehearing Conference and evidentiary hearings, as necessary. (Cal. Code Regs., tit. 20, § 1714.5.) Elected officials and members of the public may present public comments at these events and/or submit written comments via the Energy Commission's e-Filing system at: http://www.energy.ca.gov/sitingcases/palen.

All parties are **ORDERED** to file a Prehearing Conference Statement on or before 5:00 p.m. on July 21, 2014, unless otherwise directed by the Committee.

The Prehearing Conference Statement must specify under separate headings:

- 1. The issues that are complete and ready to proceed to evidentiary hearing;
- 2. The issues that are not complete and not yet ready to proceed to evidentiary hearing, and the reasons therefor;
- 3. The issues that remain disputed and require adjudication, and the precise nature of the dispute for each issue;

- 4. The identity of each witness the party intends to sponsor, the subject area(s) about which the witness(es) will testify, a brief summary of the testimony to be offered by the witness(es), qualifications of each witness, the time required to present testimony by each witness, and whether the witness seeks to testify telephonically;
- 5. Subject areas upon which the party desires to question the other parties' witness(es), a summary of the scope of the questions (including witness qualifications), the issue(s) to which the questions pertain, and the time desired to question each witness. (*Note*: A party who fails to provide the scope, relevance and time for questioning other parties' witness(es) risks preclusion from questioning on that subject area.);
- A list identifying exhibits with TN numbers that the party intends to offer into evidence and the technical subject areas to which they apply (see example attached to the 10/7/13 Notice of Prehearing Conference and Evidentiary Hearing and Hearing Orders (TN# 200758));
- 7. Proposals for briefing deadlines, impact of scheduling conflicts, or other scheduling matters; and
- 8. A description of any proposed modifications to the conditions of certification for the limited issues listed above.

All documentary evidence must be docketed and have a transaction number (TN number) assigned by the California Energy Commission Dockets Unit in accordance with the Revised General Orders Regarding Electronic Document Formats, Electronic Filing and Service of Document and Other Matters filed October 21, 2013 (TN# 200981). Exhibits without a TN number will not be received into evidence absent a showing of good cause.

Each document shall be numbered and identified as follows:

Petitioner's exhibits shall be numbered *consecutively* as **Exhibits 1124 through 1999**;

Staff's exhibits shall be numbered consecutively as Exhibits 2017 through 2999;

Intervenor Center for Biological Diversity's exhibits shall be numbered *consecutively* as **Exhibits 3091 through 3999**;

Intervenor Basin and Range Watch's exhibits shall be numbered *consecutively* as **Exhibits 4001 through 4999**;

Intervenor Californians for Renewable Energy's exhibits shall be numbered consecutively as **Exhibits 5003 through 5999**;

Intervenor California Unions for Reliable Energy's exhibits shall be numbered consecutively as **Exhibits 6000 through 6999**;

Intervenor Laborers' International Union of North America's exhibits shall be numbered consecutively as **Exhibits 7000 through 7999**; and

Intervenor Colorado River Indian Tribe's exhibits shall be numbered consecutively as **Exhibits 8028 through 8999**.

Failure of any party to comply with the filing requirements stated in this Order may preclude that party from participating in the evidentiary hearing.

Notice of Committee's Intention to Use Informal Hearing Procedures

Pursuant to Government Code, section 11445.10 et seq., and section 1217 of the Commission's regulations, the Committee intends to conduct the evidentiary hearing using an informal procedure. The parties will identify witnesses and exhibits prior to the hearing. During the hearing, all of the witnesses for a topic will be seated as a panel to answer questions from the parties and the Committee. While a question can be directed to a particular witness in the first instance, the other panelists may also answer the question if they choose. Panelists may also ask questions of each other. This format has been effective in recent cases, providing a more coherent discussion of the issues that is easier to follow for the parties, public and the Committee. The Committee reserves the right to convert to a more formal process for any issues and will, at its discretion, allow the parties to engage in more formal direct and cross examination if circumstances so require.

The informal hearing process will generally proceed in the following order:

1. All parties' experts on the topic at hand are sworn in as a panel;

2. Petitioner's experts would provide a brief opening statement summarizing the key points and conclusions of their testimony;

3. Staff's experts would provide a brief opening statement summarizing the key points and conclusions of their testimony;

4. Intervenors' experts would provide a brief opening statement summarizing the key points and conclusions of their testimony;

5. Open discussion between the expert panelists led by the Committee;

6. Attorneys may follow up with questions of their own or other expert witnesses to the extent the Committee finds the questioning productive; and

7. At the conclusion of the attorney's examination of the experts, the Committee may ask witnesses additional questions or allow panelists to ask additional questions of each other and to offer follow-up answers.

Notice of Closed Session Deliberations

At any time during the hearings, the Committee may adjourn to a closed session in accordance with Government Code, section 11126, subdivision (c)(3), which allows a

state body, including a delegated committee, to hold a closed session to deliberate on a decision to be reached in a proceeding the state body was required by law to conduct.

Transcripts

Parties are responsible for identifying errors in the transcripts of the proceedings. Corrections to the transcripts must be submitted to the Committee within 30 days of the filing of a transcript.

Public Adviser and Public Participation

Members of the public are welcome to attend and offer oral or written comments at the prehearing conference and at the evidentiary hearing. It is not necessary to be an Intervenor to participate in the public process. Parties are encouraged to submit written comments using the e-commenting system described above. Otherwise, written comments may be submitted for posting on the docket for the proceeding by handing them directly to the Public Adviser, e-mailing them to **docket@energy.ca.gov**, or by U.S. Mail to:


