Thank you for the update Mary.

We also need to request an amendment to the Henrietta license to address restrictions that have been placed on water usage by the water purveyor for the project. In essence we are restricted in our ability to use water for landscape irrigation due to the current drought conditions. I am copying Paul Marshall here since he is tracking drought related issues generally, and we have had some specific discussions related to the GWF projects specifically. I hate to "pile on" but it seems to make sense to have all of these issues addressed at the same time, so my inclination is to go ahead and file this additional request now, unless you think there is a better approach. The relevant condition related to landscape irrigation is the same in both the simple cycle license and the combined cycle license.

I am following up on our March 24, 2014, motion requesting revocation of the amended license and reinstatement of the original license for the GWF Henrietta Peaker Project. In that motion, we also requested that the staff hold off on processing the request contained in our April 16, 2013, Revised Petition to Amend the license for the project to install a reverse osmosis treatment system as a primary water treatment system to augment the existing treatment system and to modify the wastewater disposal method. I understand that it is staff's preference that we withdraw the Revised Petition to Amend and refile when we are ready to proceed with the reverse osmosis system, as opposed to leaving that portion of the Revised Petition to Amend pending. That approach is fine, and we hereby withdraw the Revised Petition to Amend filed on April 16, 2013.
