GWF Energy, LLC, the owner/operator of the Henrietta Peaker Power Plant Project, located adjacent to Pacific Gas & Electric's 70 kV Henrietta Substation approximately one mile south of Highway 198 on 25th Avenue southeast of the City of Lemoore in Kings County, has submitted a petition to transfer operational control of the Henrietta Peaker Power Plant project to Star West Generation Management Company, an affiliate of GWF Energy, LLC. GWF Energy, LLC will continue to be the party responsible for compliance with the Energy Commission's conditions of certification for the project. A representative of the new project operator has provided a declaration, under penalty of perjury, that Star West Generation Management Company agrees to comply with the conditions of certification in the Energy Commission's Decision for the Henrietta Peaker Power Plant project.

STAFF RECOMMENDATION

Staff has reviewed the petition, finds that it complies with the requirements of Title 20, section 1769 (b) of the California Code of Regulations, and recommends approval of the change in operational Control.

CONCLUSION AND ORDER

The California Energy Commission hereby adopts the staff's recommendation and approves the transfer of operational control from GWF Energy, LLC to Star West Generation Management Company.


