Dear Mr. Winklepleck:

Last March, California Energy Commission staff discussed with you and your staff the Energy Commission's licensing process and its exclusive authority to license all new or modified thermal power plant facilities, 50 megawatts or greater, in the state (Pub. Resources Code, § 25500). We also discussed with your staff what steps the city would take to license a project of this type were they the lead agency under the California Environmental Quality Act (CEQA). I have included the staff-to-staff communications as an attachment.

To ensure the Alamitos Energy Center's compliance with the city of Long Beach's applicable laws, ordinances, regulations, and standards (LORS), Energy Commission staff is continuing to seek input and guidance from city of Long Beach planning staff on what steps the city would take to permit the proposed project if the city were the lead agency under CEQA. Specifically, staff is looking to city of Long Beach staff to provide guidance on two issues:

- 1. Whether the Planned Development Zone District (PD-1), Subarea 19, and the South East Area Development Improvement Plan (SEADIP) are the applicable land use documents for this project.
- Or, as your staff has communicated to Energy Commission staff, the project would require site plan review and direction from the city council regarding project development standards, and then possible final approval by the City Council, were the city the lead agency.

The Alamitos Energy Center's Application for Certification (AFC), states that Subarea 19 (where the project is located) defers to the IG zone district (General Industrial) for project development standards, yet staff-to-staff discussions indicate this may not be the case. Energy Commission staff is looking to the city of Long Beach to provide input in an advisory capacity so our environmental analysis can ensure that the proposed Alamitos Energy Center is consistent with the city's applicable LORS and complies with the city's development standards, either as

identified in the IG zone district, or as established through the city's advisory site plan review process.

Energy Commission staff understands that a commitment of this kind could burden the planning department staff if costs for staff time is not reimbursed. Public Resources Code Section 25538 (Review by local agencies; fees; lost permit fees; reimbursement) states that,

"Upon receiving the commission's request for review under subdivision (f) of Section 25519 and Section 25506, the local agency may request a fee from the commission to reimburse the local agency for the actual and added costs of this review by the local agency. The commission shall reimburse the local agency for the added costs that shall be actually incurred by the local agency in complying with the commission's request. The local agency may also request reimbursement for permit fees that the local agency would receive but for the operation of Section 25500, provided, however, that such fees may only be requested in accordance with actual services performed by the local agency. The commission shall either request a fee from the person proposing the project or devote a special fund in its budget, for the reimbursement of such costs incurred by local agencies."

This provision would allow city staff to be compensated while providing Energy Commission staff the necessary input and guidance regarding the project's compliance with the city of Long Beach's applicable LORS. If the city of Long Beach is unable to provide the requested assistance, then Energy Commission staff will perform the LORS compliance analysis using the applicable development standards from the IG zone district, and the city will have the opportunity to comment on the Preliminary Staff Assessment (PSA) when it is published.

Dear Mr. Winklepleck,

The California Energy Commission is currently in a discovery phase for the proposed Alamitos Energy Center Re-power Project (13-AFC-01). Energy Commission staff are analyzing the proposed facility for consistency with federal, state and local laws, ordinances, regulations and standards (LORS) and would like to discuss some of the provisions of the City of Long Beach's Zoning Ordinance with you.

More specifically, staff would like clarification from city planning staff on whether the Planned Development Zone District (PD-1) or Subarea 19 of the South East Area Development Improvement Plan (SEADIP) is the guidance document for a project of this type. It is our understanding that the Planned Development Zone District (PD-1) has no development standards and would require review and approval by the City Council. Energy Commission staff is interested in finding out what development standards would be imposed on this type of project, if the City of Long Beach were the lead permitting agency.

If possible, we would like to setup a conference call with city planning staff to discuss these matters at your convenience.



AES Alamitos Facility Site Map






FIGURE 2.1-3a Elevation Drawings (Looking East) Alamitos Energy Center Long Beach, California




FIGURE 2.1-3b Elevation Drawings (Looking South) Alamitos Energy Center Long Beach, California




FIGURE 2.1-3c Elevation Drawings (Looking West) Alamitos Energy Center Long Beach, California




FIGURE 2.1-3d Elevation Drawings (Looking North) Alamitos Energy Center Long Beach, California

Also, the following is an explanation of the Energy Commission's permitting authority. In short, the Energy Commission has the exclusive authority to license all new or modified power facilities, 50 MW or greater in the state (Public Resources Code section 25500). The Energy Commission's license takes the place of all other state, regional, or local permits (e.g., conditional use permit), and other entitlements for use, that would otherwise be required. The Energy Commission's facility certification process carefully examines public health and safety, environmental impacts, and engineering aspects of proposed power plants, and all related facilities such as electric transmission lines and natural gas and water pipelines. The Energy Commission's responsibilities are those of a lead agency under the California Environmental Quality Act (CEQA), except the Energy Commission's analysis includes multiple environmental and decision documents rather than an Environmental Impact Report.

As part of the licensing process, the Energy Commission must determine whether a proposed facility complies with all applicable state, regional, and local laws, ordinances, regulations, and standards (LORS) (Public Resources Code section 25523(d)(1)). The Energy Commission must either find that a project conforms with all applicable LORS or make specific findings that a project's approval is justified even where the project is not in conformity with all applicable LORS (Public Resources Code section 25525).

I provided the expanded code sections referred to above in an attachment as well as a flow chart showing the permitting timeline/process for a power plant
