# SOLICITATION FOR AGENCY PARTICIPATION IN THE REVIEW OF AMENDMENT REQUESTS TO THE LICENSED CARLSBAD ENERGY CENTER PROJECT

On April 29 and May 2, 2014, Carlsbad Energy Center, LLC (the petitioner), an indirect wholly owned subsidiary of NRG Energy, Inc., submitted two petitions to amend the May 31, 2012 Energy Commission Decision approving the Carlsbad Energy Center Project (CECP). The Licensed CECP and the modification requests sought through the amendment petitions are described below. Both the Licensed (23-acre footprint) and the Amended CECP (30-acre footprint) would be located on the northeastern portion of the Encina Power Station (EPS) site, north of Canon Road, east of the AT&SF/North County Transit District Rail Corridor, west of Interstate-5 and south of the Agua Hedionda Lagoon, in the city of Carlsbad in San Diego County.

## Background

As licensed by the Energy Commission, the 540-megawatt (MW) CECP project is a natural gas-fired, combined-cycle power facility comprising two power blocks. Each power block would consist of one, rapid-response combustion turbine generator (CTG), one heatrecovery steam generator (HRSG), one condensing steam turbine generator (STG), an air-cooled, fin-fan heat exchange condenser, and associated support equipment and linear features. The Energy Commission has exclusive jurisdiction to license this project and is considering the amendment petitions under Title 20, California Code of Regulations, section 1769. During the amendment review period, Energy Commission staff will analyze the requested modifications to the Licensed CECP, and testify whether these changes would comply with applicable laws, ordinances, regulations and standards related to public health and safety, environmental impacts, and engineering requirements. Staff's testimony will be considered along with that of other parties, public agencies and public comments by a Committee of two Commissioners assigned to this proceeding on June 18, 2014. Based on the Committee's recommendation, the full five-member Commission will ultimately determine if the Amended CECP meets all required and applicable standards, and if the Amended CECP should receive permission for construction and operation.

#### **Proposed Project Changes**

The petitioner first seeks to change the Licensed CECP's generation equipment from two, combined-cycle power blocks, to six, simple-cycle turbines. This electrical generation change will allow for a more flexible facility that can reach full output capacity in a timelier manner, enabling for increased integration of renewable energy sources that are intermittent in nature. Local generation reliability will also increase, as will regional transmission system integrity. As noted earlier, the Amended CECP footprint will increase by seven acres (30 acres total), covering the entire existing EPS eastern tank farm (comprising above-ground oil storage tanks 4, 5, 6 & 7). Tank 4 accounts for the additional acreage, which will house new simple-cycle units 6 and 7 (output will be stepped up to a

138kV transmission line, with units 8, 9, 10 and 11 stepped up to a 280kV transmission line). Transmission components and alignments will not be modified from the licensed CECP. Components that petitioner does seek to modify include the preferential use of Title 22 reclaimed water which will now be available from the Encina Wastewater Authority (EWA). The reclaimed water would be delivered via a new, 3,600 foot-long pipeline connecting the EWA reclaimed water to the Amended CECP. Lastly, all necessary components, including the operations center, warehouse, and small desalination facility, will now all be constructed east of the railroad tracks on the larger 30-acre Amended CECP parcel.

Following commercial operation of the Amended CECP generation facility (expected to occur in late 2017 following construction and commissioning activities), the Petitioner seeks permission to commence demolition activities of the existing EPS facilities west of the railroad tracks, beginning with the 12 story EPS building and its 400-foot exhaust stack. Demolition and any associated remediation activities would be followed by title transfer from the petitioner to the city of Carlsbad for joint, non-power site redevelopment. Upon completion of demolition activities, specific redevelopment of the acreage west of the railroad tracks will occur under the authority of other jurisdictional bodies. Ultimately, redevelopment will promote economic development while enhancing open space along Agua Hedionda Lagoon and increasing access to the beach in a manner consistent with Carlsbad's beach community character.
