I. Name: Matt Binner

II. <u>Purpose</u>:

I provide this Supplemental Rebuttal Testimony to address the issues relating to glint and glare raised by the CEC Staff in its Supplemental Staff Assessment and Opening Testimony for the Palen Solar Electric Generating System (PSEGS) (09-AFC-7C).

III. Qualifications:

I have over eight years of experience as a pilot. My qualifications are detailed in my attached resume. To the best of my knowledge all referenced documents and all of the facts contained in this testimony are true and correct. To the extent this testimony contains opinions, such opinions are my own. I make these statements and provide these opinions freely and under oath for the purpose of constituting sworn testimony in this proceeding.

IV. **Opinions and Conclusions**:

Between October 2010 and February 2014, my company pilots and I flew over the Ivanpah project a total of at least eight times. All of our flights were in a helicopter (Schweizer 300C, Robinson R- 22 or R-44). Here are some of the known specific flight dates:

6/5/12

10/27/12

3/19/13

6/25/13

9/5/13

11/4/13

5/9/14

We have flown over the site during all phases of the project, from initial construction through commissioning and full operations. My flights originated from the North Las Vegas airport with the Jean airport often used for refueling.

Each time, I flew over the Ivanpah site and extensively around the desert basin that also contains Interstate 15, Primm, etc. My altitude ranged from 500 to 6000 feet above the site.

We flew at dawn, sunrise, midday, late afternoon and dusk. Since September 2013, during most of my flights we witnessed flux testing or power production at the Ivanpah site. Never, during any of these flights, did I experience unsafe flying conditions because of reflections, glint or glare, from Ivanpah, heliostats or towers. The rule for all of my flights was and is safety first.

That said, I treated the site with respect following common sense rules to avoid looking at the sun or its reflection directly - rules which all experienced pilots should be familiar with and should follow.
